

## PROMOTION TERMS AND CONDITIONS

('TPV'), with its registered offices at Bernhardplein 200, 1097 JB, Amsterdam, The Netherlands or its fully owned subsidiaries about the Promotion (defined below) at [www.Phillips-promotions.com/tvandaudiocashback](http://www.Phillips-promotions.com/tvandaudiocashback) form part of the Terms and Conditions.

## THE PROMOTION

- Participants who subject to these Terms and Conditions:
  - purchase a Qualifying TV from a Participating Retailer (both defined below) between 00:01 1 September 2021 and 23:59 31 December 2021; and
  - either in the same transaction or within 90 days of the date of purchase of the Qualifying TV (date of purchase counts as day 1) purchase one or more Qualifying Audio Products (maximum of 1 (one) Soundbar and up to 2 (two) speakers) subject to the limits at condition 7) directly from any Participating Retailer;

## ELIGIBILITY

4. The Promotion is only open to UK residents aged 18 or over ('Participant'), except:
  - (a) employees of TPV or its holding or subsidiary companies;
  - (b) employees of agents or suppliers of TPV or its holding or subsidiary companies, who are professionally connected with the Promotion or its administration; or
  - (c) members of the immediate families or households of (a) and (b) above.
5. Businesses are excluded from participating in this Promotion.
6. A claim must be made by the Participant, and must not be:
  - (a) submitted through agents, retailers, resellers;
  - (b) automatically generated by computer;

(c) completed by third parties or in bulk; or are

(d) illegible, have been altered, reconstructed, forged, or tampered with.

## **ENTRY**

9. To be eligible for a Reward each Qualifying Audio Product must be purchased within 90 days of the date of purchase of the Qualifying TV. The date of purchase counts as day 1 (one).
10. Participants may only submit a claim for a Reward between thirty (30) and sixty (60) calendar days of the date of purchase of a Qualifying Audio Product. Between the thirty (30) to sixty (60) calendar days waiting period, Participants must complete and submit the claim form available at [www.philips-promotions.com/tvandaudiocashback](http://www.philips-promotions.com/tvandaudiocashback) ('Website'). In order to complete the claim form, the Participant must provide the details requested including the serial number of the Qualifying Audio Product(s), details of their UK bank account where the Reward shall be paid and upload a copy of their proof of purchase of the Qualifying TV and Qualifying Audio Product in the form of a receipt(s) or invoice(s) from the Participating Retailer. Complete claim form information and proof of purchase must be received on or before 23:59 on day 60 from the date of purchase of the relevant Qualifying Audio Product to be eligible to claim for a Reward. If a claim is deemed not to have been submitted correctly, the Participant will be notified via email and offered the opportunity to provide the required information within seven (7) calendar days of receipt of the email. If no response is received within seven (7) calendar days of the email being sent, then the claim shall be marked as invalid, and the Participant will no longer be eligible to receive the Reward. It is the Participant's responsibility to contact us if the Participant has not received an update on the status of the Participant's claim within seven (7) calendar days.

16. Subject to condition 15 above, claims that are incomplete will be deemed invalid. TPV or the Administrator are not responsible for lost, delayed or damaged data which occurs during any communication or transmission of claims.
